## OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

May 2, 2017

9:00 AM

Chairman Medalen called the meeting to order. Commissioners Harry Bergstad, David Medalen, Gregg Boutilier, Larry Haman and Bryan Bruner were present.

A motion was made by Bergstad and seconded by Boutilier to approve the April 4<sup>th</sup> and April 11<sup>th</sup> minutes. Motion carried unanimously.

Mary Hanretty met with the board to present information on Breathe ND and the Tobacco Coalition.

Sam Welch with S E H Engineering met with the board to inquire about future job opportunities.

Normal Township supervisors Vance Prellwitz, Steve Pollman and Richard Uran met with the board to discuss road issues. They requested the county blade discontinue pushing trees in the ditch, as they are working with a contractor to remove them. They also mentioned rocks are being pulled from the shoulders to the top of the road, and requested the crown on a few roads be lowered and the road widened. Richard Uran requested a culvert be lowered. The commissioners referred him to the water board.

Duane Drader met with the board to discuss the damage to one of his buildings.

A motion was made by Bergstad and seconded by Bruner to approve road work on the boarder of Newport and Red Cross Townships. Motion carried unanimously.

The board reviewed an application for a conditional use permit to set up a portable asphalt plant in the E <sup>1</sup>/<sub>2</sub> NW <sup>1</sup>/<sub>4</sub> of Sec 35-155-77 and an application for a variance permit to place an additional non-farm dwelling in the SE <sup>1</sup>/<sub>4</sub> SE <sup>1</sup>/<sub>4</sub> of Section 18-154-79. The public hearings were held by the zoning board with no opposition. A motion was made by Boutilier and seconded by Bergstad to approve both permits. Motion carried unanimously.

The board reviewed abatements 1230 and 1231. A motion was made by Bergstad and seconded by Medalen to lower the value to \$1,000 for the structure. Motion carried unanimously. The board reviewed abatement #1244. A motion was made by Boutilier and seconded by Bruner to leave \$1,000 on the structure. Commissioners Bergstad, Boutilier, Bruner and Medalen voting aye. Commissioner Haman absent. Motion carried. A motion was made by Bergstad and seconded by Bruner to approve abatement #1241. Motion carried unanimously.

Leanna Emmer with NDLTAP met with the board regarding programs offered through their organization.

The board recessed for lunch.

Denver Fosness and Kelsey Siegler joined the meeting.

The board opened the estimates for the various county road projects in Deep River, Meadow, Little Deep and Pratt Townships. A motion was made by Haman and seconded by Bergstad to accept the estimate from Fosness Construction for the Deep River projects. Motion carried unanimously. A motion was made by Medalen and seconded by Bruner to accept the estimate from Fosness Construction for the Meadow Township work. Motion carried unanimously. A motion was made by Medalen and seconded by Bergstad to accept the estimate from Woodall Dirtworks for the Little Deep Township work. Motion carried unanimously. A motion was made by Medalen and seconded by Boutilier to accept the estimate from Woodall Dirtworks for the Pratt Township work. Motion carried unanimously. Kelsey Siegler, EM/911 Coordinator met with the board to discuss the Reverse 911 system for the county. Everbridge is requiring the county to determine if they wish to continue to contract with them for services and at which level of functionality. A motion was made by Bergstad and seconded by Boutilier to choose to continue with Everbridge with Option C, which would be the highest level of functionality at an estimated annual cost of \$1,700/year. Motion carried unanimously.

A motion was made by Boutilier and seconded by Haman to sign the Notice of Award for CNOC-2506(064) and the contract for construction. Motion carried unanimously.

SRF Consulting inquired about continuing the contracting for Planning and Zoning consulting, which would allocate the unused funds approved in 2016. A motion was made by Boutilier and seconded by Bruner to continue with the contract for 2017. Motion carried unanimously.

An invoice was received from WE Integrate. A motion was made by Bergstad and seconded by Boutilier to deny payment since the problem was found in the wiring which is no fault of the county. Motion carried unanimously.

Kent Indvik from Wold Engineering met with the board. A motion was made by Bergstad and seconded by Bruner to approve change order 1 on project CNOC-2506(064) to add a chipseal and fog coat to the new pavement West of Upham. Motion carried unanimously.

A motion was made by Bruner and seconded by Haman to put an approach on the North side of the road in Section 23 of Deep River Township. Motion carried unanimously.

A motion was made by Boutilier and seconded by Haman to reappoint Darlene Guss and David Medalen to the McHenry County Social Service Board. Commissioners Bergstad, Bruner, Haman and Boutilier voting aye. Commissioner Medalen abstained. Motion carried.

The board discussed the bridge located on the West side of Section 35 in Balfour Township. The board will contact the Water Board for their opinion.

A motion was made by Haman and seconded by Bruner to sign the construction engineering contract with Wold Engineering for the BRO-0025(011) project. Motion carried unanimously.

A consent motion was made by Bruner and seconded by Haman to approve the following receipts: Treasurer's Miscellaneous Receipts #41573-41657 the monthly payroll in the amount of \$161,206.07 paid by warrant checks #23516-23581 and Social Service bills totaling \$4,322.66; Clerk of Court March County fees \$730.25, State fees \$12,812.07; Clerk of Court April County fees \$394.96, State fees \$9,595.31; County Recorder March recording fees of \$2,599.00 and misc fees of \$288.60; County Recorder April recording fees of \$1,198.50 and misc fees of \$243.20; Sheriff April statement of fees \$460.00, Sheriffs mileage \$424.00; Deputy reports for Mar/Apr.

The board continued to audit bills until completed. It was then moved by Bruner and seconded by Bergstad that the following bills be approved and the proper checks be issued thereof:
