OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

October 3, 2017

9:00 AM

Chairman Medalen called the meeting to order. Commissioners Harry Bergstad, David Medalen, Gregg Boutilier, Larry Haman and Bryan Bruner were present. Also present was Josh Frey.

A motion was made by Boutilier and seconded by Bergstad to approve the September 5th and 14th minutes. Motion carried unanimously.

Information was presented to the board regarding North Prairie Rural Water's opposition to a conditional use application for a gravel pit East of Velva.

The board considered the conditional use application from Sundre Sand and Gravel to mine sand and gravel in NE ¼ of Sec 36-153-80 and in the SE ¼ of Sec 25-153-80. A list of others in attendance is on file in the auditor's office. Individuals representing North Prairie Rural Water and the City of Velva mentioned the proposed mining would be within the wellhead protection area. North Prairie stated they would have no opposition if the mining would take place outside their wellhead protection area. This might be possible but it is not possible to mine outside the Velva protection area. A letter was received from the McHenry County Water Board chairman stating, in his opinion, the mining should have no negative impacts with the water associated with the wellhead if it takes place at least five feet above the water table. A letter was also received from the City Engineer stating the City of Velva is not in favor of this application, but if it is approved, offered a suggestion that a dome shaped finish be developed over the mining area to allow run off to flow away from the pit area. A motion was made by Medalen and seconded by Boutilier to deny the application. Commissioners Medalen, Bruner, Bergstad and Boutilier voted aye. Commissioner Haman voted nay. Motion carried.

The hearing was held for the 2018 county budget. No one appeared for or against the proposed budget. A motion was made by Boutilier and seconded by Bergstad to approve the budget. Motion carried unanimously.

Tina Powell presented the board with her compensation findings, as requested at the last meeting.

A motion was made by Boutilier and seconded by Bruner to approve the utility permit for Verendrye Electric to bore under Co Rd 5 between sections 7/8 in 157-75. Commissioners Medalen, Bruner, Haman and Boutilier voted aye. Commissioner Bergstad absent. Motion carried.

The public hearing was held to close the section line between sections 6/7 in 157-76. James Haman, Duane Drader, Chris Jorde, and an out-of-state hunter joined the meeting. Letters of opposition were also received from two other out-of-state hunters, as well as James Jorde. Duane, Chris and the hunter spoke in opposition of closing the section line. States Attorney, Josh Frey, reviewed the century code requirements to close a section line, one of which is a public benefit must be provided. A motion was made by Bergstad and seconded by Boutilier to deny the request to close the section line based on the law since there is not a public benefit. Motion carried unanimously.

A petition from Roland Bromley was received to close a section line located between sections 27/34 in 153-75. A motion was made by Haman and seconded by Bruner to advertise for a public hearing. Motion carried unanimously.

A motion was made by Boutilier and seconded by Haman to appoint Jerry Effertz and Joan Gunter as county delegates to the ND State Fair Board. Motion carried unanimously.

Vance Prellwitz, Dick Anderson, Richard Uran and Mike McIntee joined the meeting to discuss the water crossing between sections 21/22 in 158-75. McIntee requested a hydrology study be completed by the state engineer. A motion was made by Haman and seconded by Boutilier to question the state on the costs associated with doing a study, and if there is no cost, to complete a study to determine if the site has the appropriate number of culverts, with proper sizes and installation. Motion carried unanimously.

Kent Indvik met with the board to update the board on the county road projects.

The board recessed for lunch.

The board reviewed the list of foreclosed properties and set the minimum sales prices. A motion was made by Boutilier and seconded by Bruner to approve the minimum sale prices as determined. Motion carried unanimously.

A motion was made by Bergstad and seconded by Haman to allocate \$7,500 to the Souris River Joint Board for 2018. Commissioners Bergstad, Haman and Bruner voted aye. Commissioners Boutilier and Medalen voted nay. Motion carried.

A motion was made by Bergstad and seconded by Bruner to extend the culverts between sections 4/5 in 151-78. Motion carried unanimously.

A consent motion was made by Bruner and seconded by Haman to approve the following receipts: Treasurer's Miscellaneous Receipts #41975-42056 the monthly payroll in the amount of \$159,584.23 paid by warrant checks #23838-23893 and Social Service bills totaling \$4,922.91; Clerk of Court September County fees \$565.00, State fees \$9,137.00, City of Towner \$20.00; County Recorder September recording fees of \$5,310.00 and misc fees of \$180.95; Sheriff September statement of fees \$580.00, Sheriffs mileage \$659.00; Deputy reports for September.
