OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

April 3, 2018

9:00 AM

Chairman Medalen called the meeting to order. Commissioners David Medalen, Harry Bergstad, Larry Haman, Bryan Bruner and Gregg Boutilier were present. States Attorney Josh Frey was also present.

A motion was made by Haman and seconded by Bergstad to approve the March 6th and 21st minutes. Motion carried unanimously.

A motion was made by Bruner and seconded by Boutilier to approve the agenda. Motion carried unanimously.

Larry Mortensen with Maintenance Engineering met with the board to propose LED lighting in the courthouse and county shops.

A motion was made by Boutilier and seconded by Bergstad to approve the gaming site authorization for the Velva volunteer fire department. Motion carried unanimously.

A motion was made by Boutilier and seconded by Bergstad to approve the Construction and Maintenance agreement with NDDOT for project SC-2500(018). Motion carried unanimously.

A motion was made by Bergstad and seconded by Haman to approve abatements 1278-1280 and 1284. Motion carried unanimously.

Community Service Coordinator, Allan Meckle, met with the board to present an update on the community service program.

The board contacted Bill Behling, Project Manager for the New Frontier Wind Energy Project regarding the road use agreements for the county and affected townships.

Due to the tie vote regarding the motion made by Medalen and seconded by Haman to not lease a tractor for mowing this summer, it was brought before the full board for another vote. Commissioners Medalen and Haman voting aye. Commissioners Bruner, Bergstad and Boutilier voting nay. A tractor will be leased.

Josh Frey asked the board of their intent with summer hours. A motion was made by Boutilier and seconded by Bergstad to approve the summer hour policy as implemented last year. Motion carried unanimously.

Kent Indvik joined the meeting to present an update on the county road projects. A motion was made by Bergstad and seconded by Bruner to declare the short stretch of road on 14th Ave N between Hwy 52 and Hwy 97 as a county road and to request NDDOT add it to the county Federal Aid system. Motion carried unanimously.

The board recessed for lunch.

A motion was made by Boutilier and seconded by Bergstad to hold the county vehicle sale for June 16th at 10:00 AM. Motion carried unanimously.

A motion was made by Boutilier and seconded by Bergstad to advertise the used grader blades on bids. Motion carried unanimously.

Linda Fairbrother proposed a new credit card company the county can contract with which would offer lower fees for the consumer.

Stacey Schmitt met with the board to discuss the status of the Tax Director's office.

States Attorney, Josh Frey, approached the board to inquire about the possibility of running for States Attorney in another county, as well as in McHenry. A motion was made by Bergstad and seconded by Boutilier to allow him to pursue the dual States Attorney option and to run in McHenry and Towner Counties. Motion carried unanimously.

Due to the States Attorney's conflict of interest, the board contacted Kathleen Murray regarding an employment issue.

A motion was made by Bergstad and seconded by Boutilier to deny the mileage request for Jerry Hansen on March 8th. Motion carried unanimously.

A motion was made by Haman and seconded by Bruner to advertise the tree removal in Poplar Grove and Hougom Townships. Motion carried unanimously.

A motion was made by Boutilier and seconded by Bergstad to furnish the Towner Fire Department with an approach along Co Rd 5, just North of the water tower. Motion carried unanimously.

A consent motion was made by Bruner and seconded by Bergstad to approve the following: Treasurer's Miscellaneous Receipts #42436-42488; the monthly payroll in the amount of \$161,657.11 paid by warrant checks #24197 – 24262 and Social Service bills totaling \$5,175.03; Clerk of Court Mar County fees \$515.00, State fees \$7,810.97; County Recorder March recording fees of \$4,930.00 and misc fees of \$1,162.90; Sheriff's March statement of fees \$543.75, Sheriffs mileage \$352.00; Deputy reports for March.
