OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

January 2, 2018

9:00 AM

Chairman Medalen called the meeting to order. Commissioners Harry Bergstad, David Medalen, Larry Haman, Gregg Boutilier and Bryan Bruner were present. Also present was Josh Frey.

A motion was made by Haman and seconded by Bergstad to approve the December 5th and 19th minutes. Motion carried unanimously.

A motion was made by Haman and seconded by Bergstad to issue the proper deed to Kidsquarters LLC for the redemption of county land described as Lots 11 and 12 of Block 13 in Original Velva. Motion carried unanimously.

A motion was made by Bergstad and seconded by Bruner to issue the proper deed to the City of Velva for the sale of county land described as Lots 1 and 2 of Block 1 in Original Velva, and to cancel any remaining taxes. Motion carried unanimously.

Abatements #1262-1268 were presented before the board, which would remove the value of personal property erroneously placed on the parcels. A motion was made by Bergstad and seconded by Haman to approve the abatements. Motion carried unanimously.

A motion was made by Boutilier and seconded by Bruner to approve the pledge of assets from Western Bank. Motion carried unanimously.

The board reviewed the proposal for public depositories received from Western Banks. A motion was made by Bruner and seconded by Haman to approve Western Bank as the depository for McHenry County for 2017-18. Motion carried unanimously.

John Rognlien, Harry Nelson and Stacy Jaeger from the Eaton Irrigation Board met with the commissioners regarding the status of a current board member. Commissioner Medalen will look into this matter. The board also discussed a drainage ditch used for Eaton Irrigation purposes and owned by the county. It has not been determined why the county owns the ditch, but an effort will be made to sell it to the adjoining land owners. The Eaton Board members requested all records of the Eaton Irrigation District be stored at the courthouse. The commissioners agreed, but stated the county will not be responsible for them.

Rachel Wald, Callie Johnson and Ron Wiederholt joined the meeting to discuss the new cost-share proposal from NDSU for the extension program.

A motion was made by Boutilier and seconded by Bergstad to make the following amendments to the 2017 budget: Road & Bridge from \$1,334,300 to \$1,466,399.20, 2011 Flood Disaster from \$99,502 to \$114,015.03, Job Development Authority from \$41,000 to \$48,743.50, 911 from \$70,765 to \$76,658.67, Emergency Fund from \$10,000 to \$124,614.40, Weed Board from \$369,000 to \$469,419.76. Motion carried unanimously.

The board recessed for lunch.

A consent motion was made by Bergstad and seconded by Bruner to approve the following: Treasurer's Miscellaneous Receipts #42246-422308; the monthly payroll in the amount of \$156,855.56 paid by warrant checks #24021 – 24076 and Social Service bills totaling \$933.11; Clerk of Court Dec County fees \$254.34, State fees \$8,782.37; Sheriffs December statement of fees \$757.50, Sheriffs mileage \$667.00; Deputy reports for Nov/Dec.

The board continued to audit bills until completed. A motion was made by Bruner and seconded by Haman that the following bills be approved and the proper checks be issued thereof:
