OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

July 3, 2018 9:00 AM

Chairman Medalen called the meeting to order. Commissioners David Medalen, Harry Bergstad, Larry Haman, Bryan Bruner and Gregg Boutilier were present.

A motion was made by Boutilier and seconded by Haman to approve the June 5 and 22nd minutes. Motion carried unanimously.

The board reviewed the zoning variance received from Johan Haman to plant a shelterbelt 75' from the center of 8th Ave NE in the SE ¼ SE ¼ of Section 27-156-76. The zoning board held the public hearing, with no one appearing in opposition. A recommendation was made to approve the variance. A motion was made by Boutilier and seconded by Bruner to approve the variance as recommended by the zoning board. Motion carried unanimously.

Josh Frey met with the board to discuss zoning issues regarding a marijuana policy.

Abatements #1285-1288 were presented to the board. A motion was made by Bergstad and seconded by Haman to approve all abatements. Motion carried unanimously.

A motion was made by Bergstad and seconded by Bruner to accept and sign the contract and contract bond for the seal coat project East and South of Velva. Motion carried unanimously.

Callie Johnson met with the board to discuss the probability of a different car and to request the presence of the commissioners at a meeting with NDSU Extension and legislators on September 4th at 1:00 PM.

A motion was made by Haman and seconded by Bergstad to appoint Shawn Anderson to the County Zoning Board. Motion carried unanimously.

The board discussed the expenses and time spent by our Veteran Service Officer for servicing Ward County veterans. Ward County has been informed of these concerns.

A motion was made by Boutilier and seconded by Bergstad to advertise for bids the removal of logjams at the Hutton and Howe Bridges. Motion carried unanimously.

Trey Skager, Aaron Nord and the dog joined the meeting. Trey talked about ordering two new cars this fall but they wouldn't be paid for until sometime in 2019.

A motion was made by Boutilier and seconded by Bruner to advertise for bids to restripe the county highway from Granville, North 22 miles. Motion carried unanimously.

Greg Hagen representing Wold Engineering met with the board with project updates.

The board set a budget workday for July 17th at 9:00 AM.

Estimates were received on replacing the sidewalk in front of the county health nurse office. A motion was made by Bergstad and seconded by Boutilier to accept the low bid from JDM Concrete in the amount of 2,400.00. Motion carried unanimously.

A consent motion was made by Haman and seconded by Bergstad to approve the following: Treasurer's Miscellaneous Receipts #42676-42758; the monthly payroll in the amount of \$161,784.43 paid by warrant checks #24389 – 24451 and Social Service bills totaling \$4,113.12; Clerk of Court June County fees \$540.00, State fees \$11,619.80; Sheriff's June statement of fees \$747.81, Sheriff's mileage \$849.00; Deputy reports for May/June.

The board continued to audit bills until completed. A motion was made by Bruner and seconded by Boutilier that the following bills be approved and the proper checks be issued thereof:
