OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

May 7, 2019 9:00 AM

Chairman Bruner called the meeting to order. Commissioners Gregg Boutilier, Harry Bergstad, David Medalen, Larry Haman and Bryan Bruner were present.

A motion was made by Medalen and seconded by Bergstad to approve the minutes from the April 2^{nd} , April 11^{th} and April 18^{th} meetings. Motion carried unanimously.

Leon Schultz met with the board regarding their offer of the Road Maintenance Supervisor position. Discussion was held regarding the position requirements and it being classified as seasonal. Leon thanked the board for their offer, but declined the position.

Doug Woodall and Leslie Kitzman, Saline Township board members, met with the board regarding road maintenance concerns. They are also planning to work on 13th Ave N by the weather ball and asked for maintainer assistance from the county. The county agreed to provide assistance.

Jason Mayfield with Wold Engineering, Steve Jacobson with B & J Excavating, and Max Weppler with Dig It Up Backhoe joined the meeting for the bid opening on the Deep River low water crossing. The suppliers of the headwall just notified the engineers they cannot give a quote on the cost of the headwall due to the specs of the project. Due to the short notice and lack of time to change the specs, a motion was made by Medalen and seconded by Boutilier to reject all bids and rebid it for June 4th with amended specs for the headwall. Motion carried unanimously. A motion was made by Medalen and seconded by Harry to approve the preliminary and construction engineering contract with Wold Engineering for SC-2500(019), which is the Karlsruhe chipseal project.

Granville City Mayor Corey Long and Rodney Swallers joined the meeting to discuss the foreclosed county property on the North end of Main Street in Granville, as well as the rented corral panels used to secure the property.

Mary Eaton and Joel Young with Asgard Resources joined the meeting to discuss the CUP and variance zoning application. The zoning board recommended the permits be approved pending the following stipulations: the setbacks be changed from 120' to 150', proof of reclamation plan with the landowner, permit from Fish & Wildlife, permit from the Historical Society, a traffic study be done for Hwy 2, and a permit from the State Water Commission. Joel stated the setbacks have been changed to 150' and have provided the county with a copy of the correspondence with Fish & Wildlife and the State Historical Society. They also have an air quality permit, but the state has the wrong legal description so they are correcting that. The board stated they cannot approve the county permit until the State Water Commission approves their permit.

Helen Lehmann met with the board with a request to purchase a scanner which would cost approximately \$20,000 to scan the large books and enable them to get them into the NDRIN system and also for preservation purposes. The cost would be paid from the document preservation fund. A motion was made by Haman and seconded by Boutilier to grant the request. Motion carried unanimously.

A motion was made by Bergstad and seconded by Medalen to award SC-2500(019) to Asphalt Surface Technologies in the amount of \$281,802.07 to sealcoat a portion of the Karlsruhe pavement. Motion carried unanimously.

A motion was made by Medalen and seconded by Bergstad to approve floodplain permit #19 to replace a low water crossing between sections 13/24 in 159-79. Motion carried unanimously.

A motion was made by Haman and seconded by Medalen to reappoint Raymond Jaeger to the Eaton Irrigation District Board. Motion carried unanimously.

A motion was made by Medalen and seconded by Boutilier to reappoint Loren Hammer to the Social Service Board. Motion carried unanimously.

A motion was made by Boutilier and seconded by Haman to set June 11th as the election date for the question of dissolving Bantry City. The polls will be open from 12:00 PM to 7:00 PM. Motion carried unanimously. A motion was made by Boutilier and seconded by Bergstad to appoint Stacey Schmitt and Jenna Johnson to the election board. Motion carried unanimously.

A motion was made by Haman and seconded by Boutilier to amend the motion made at the April 2nd meeting which stated "to lease one motorgrader with hydraulic controls.....and three motorgraders with electronic controls" to the county shall lease two motorgrader with hydraulic controls and two motorgraders with electronic controls. Motion carried unanimously.

The board recessed for lunch.

Sheriff Skager met with the board. He informed the board of a deputy vehicle/deer accident which incurred substantial damage to the county vehicle. Skager briefly talked about the Stonegarden grant. The county abandoned vehicle sale was moved to September.

Ryan Ammermann with Southern Power joined the meeting. The board reviewed the CUP application, which was recommended for approval by the zoning board. A motion was made by Bergstad and seconded by Bruner to approve. Commissioners Bruner, Bergstad, Haman and Medalen voting aye. Commissioner Boutilier absent. Motion carried.

Joel Young with Asgard Resources stopped in again to meet with the board. He was inquiring about the setback distance from property lines for the purpose of building a road. The board contacted the zoning chairman and the consensus was 20' from the property line. He informed the board if the state does not approve a water use permit, they would truck the water in, in which one load would last 3 days for their process. A motion was made by Haman and seconded by Boutilier to approve the CUP and variance for one year with the stipulation if a water permit is not approved by the State Water Commission, water must be hauled from a certified source and the water in the area must be quality tested twice a year. Motion carried unanimously.

A motion was made by Bergstad and seconded by Haman to sign the contract with VBI for the county's employee assistance program. Motion carried unanimously.

The board reviewed the CUP application from Aggregate Construction to mine gravel in the NE ¼ of Section 34-155-77. The zoning board recommended the permit be approved. A motion was made by Haman and seconded by Bruner to approve the CUP. Motion carried unanimously.

A motion was made by Bergstad and seconded by Boutilier to purchase a disc mower for \$13,750 to mow county roads. Motion carried unanimously.

Stacey Schmitt joined the meeting to present the abatements along with the Tax Director's recommendations. A motion was made by Haman and seconded by Bergstad to approve abatements 1298, 1304 and 1305 according to the Tax Director's recommendations. Motion carried unanimously. A motion was made by Bergstad and seconded by Bruner to approve abatements 1308-1311. Motion carried unanimously.

A motion was made by Haman and seconded by Bergstad to advertise for bids for a 54' X 65' pole structure. Commissioners Bruner, Bergstad, Haman and Medalen voting aye. Commissioner Boutilier voting nay. Motion carried.

Commissioner Bergstad left the meeting.

Commissioner Medalen requested to gravel two miles on the Upham/Willow road, 1.5 miles on the Bantry/Glenburn road, and ½ mile in Red Cross Township. A motion was made by Haman and seconded by Bruner to approve. Commissioners Bruner, Haman, Medalen and Boutilier voting aye. Motion carried.

Commissioner Medalen left the meeting.

A motion was made by Boutilier and seconded by Bruner to table the opioid litigation proposal. Commissioners Bruner, Haman and Boutilier voting aye. Motion carried.

A motion was made by Haman and seconded by Boutilier to advertise for bids to remodel the Social Service office. Commissioner Bruner, Haman and Boutilier voting aye. Motion carried.

A consent motion was made by Boutilier and seconded by Haman to approve the following receipts: Treasurer's Miscellaneous Receipts #43473-43568, the monthly payroll in the amount of \$149,816.93 paid by warrant checks #25021-25081, and Social Service bills totaling \$16,537.71; Clerk of Court March County fees \$575.00, State fees \$13,623.55; Clerk of Court April County fees \$385.00, State fees \$9,021.93; County Recorder April recording fees of \$6,399.00 and misc fees of \$823.90; Sheriff March statement of fees \$400.00, Sheriffs mileage \$737.00; Sheriff April statement of fees \$499.00, Sheriffs mileage \$471.00; Deputy reports for April.

The board continued to audit bills until completed. It was then moved by Haman and seconded by Boutilier that the following bills be approved and the proper checks be issued thereof:
