OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

November 5, 2019

9:00 AM

Chairman Bruner called the meeting to order. Commissioners David Medalen, Harry Bergstad, Larry Haman, Bryan Bruner and Gregg Boutilier were present.

A motion was made by Medalen and seconded by Bergstad to approve the October 1st minutes. Motion carried unanimously.

A motion was made by Bergstad and seconded by Bruner to approve Homestead Credit abatements #1318 and #1322. Motion carried unanimously.

A motion was made by Haman and seconded by Bergstad to issue the proper deeds to Travis Berg and Jason Schultz for the redemption of county property described as East 90' of Lots 7-11 of Block 25 in White's 2nd Addition to Towner. Motion carried unanimously.

A motion was made by Bergstad and seconded by Bruner to approve a raffle permit for the Velva Wildlife Club. Motion carried unanimously.

Commissioner Bergstad introduced a resolution of support for the McHenry County Historical Society with Commissioner Medalen moving its adoption. Upon roll call, all commissioners voting "aye", this resolution was declared adopted by the Board of Commissioners.

Correspondence was received from the ND Department of Health with notice to terminate the office lease agreement.

A motion was made by Medalen and seconded by Bergstad to purchase a diesel tank for the Towner shop for approximately \$1,400. Motion carried unanimously.

A motion was made by Bergstad and seconded by Haman to sign the Human Service Zone Agreement. Motion carried unanimously.

The public hearing was held regarding the prices set for the county land sale. With no one appearing, the prices will remain as set.

The board discussed the inclement weather policy as requested by the interim Social Service Director. Closures for storms will be made on a case by case basis.

A motion was made by Bergstad and seconded by Boutilier to enter into the tractor lease program for 2020. Commissioners Bergstad, Bruner and Boutilier voting aye. Commissioners Medalen and Haman voting nay. Motion carried.

Kent Indvik with Wold Engineering met with the board to report the Karlsruhe sealcoat project and the Upham box culvert project has been completed. The board discussed projects for 2020. A motion was made by Medalen and seconded by Boutilier to micro mill, crack seal and double sealcoat from Upham, five miles West and five miles South. Motion carried unanimously.

The board recessed for lunch.

The annual renewal from LeierGIStics for the website and GIS support was presented to the board. A motion was made by Medalen and seconded by Haman to not renew the contract and to look into other options for support of these items. Commissioners Bergstad and Haman voting nay. Commissioners Medalen, Bruner and Boutilier voting aye. Motion carried.

A motion was made by Boutilier and seconded by Bergstad to advertise for bids to remove the logiam at the Falsen Bridge. Motion carried unanimously.

A motion was made by Bruner and seconded by Haman that treasurer's checks can only be issued for departmental refunds. Motion carried unanimously.

A consent motion was made by Bergstad and seconded by Medalen to approve the following: Treasurer's Miscellaneous Receipts #44050-44138; the monthly payroll in the amount of \$147,831.92 paid by warrant checks #25396-25448 and Social Service bills totaling \$4,709.25; Clerk of Court October County fees \$791.69, State fees \$11,929.69, State Dept of Trust Lands \$250.00; County Recorder October recording fees of \$4,243.00 and misc fees of \$488.70; Sheriff Deputy reports for Sept/Oct.

The board continued to audit bills until completed. A motion was made by Medalen and seconded by Haman that the following bills be approved and the proper checks be issued thereof:
