OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

October 1, 2019

9:00 AM

Chairman Bruner called the meeting to order. Commissioners David Medalen, Harry Bergstad, Larry Haman, Bryan Bruner and Gregg Boutilier were present.

A motion was made by Medalen and seconded by Haman to approve the September 3rd minutes. Motion carried unanimously.

A motion was made by Medalen and seconded by Bergstad to sign the Memorandum of Understanding with the ND Game & Fish Department, whereas the county agrees to maintain the fishing piers at the county parks. Motion carried unanimously.

A motion was made by Boutilier and seconded by Haman to sign the contract with HACTC for a prisoner board fee of \$75/day, effective 1-1-20 through 12-31-21. Motion carried unanimously.

Abatements #1319 and #1320 were presented to the board to remove the residential values on the property due to the buyout through the StARR program. Abatement #1321 was presented for a Homestead Credit. A motion was made by Bergstad and seconded by Medalen to approve all abatements. Motion carried unanimously.

A motion was made by Bergstad and seconded by Medalen to reappoint Jerry Effertz and Joan Gunter to represent McHenry County on the State Fair Board. Motion carried unanimously.

A motion was made by Boutilier and seconded by Bergstad to approve the utility permit from Verendrye Electric to bore under Co Rd 18 between sections 1/12 in 156-78. Motion carried unanimously.

A motion was made by Boutilier and seconded by Medalen to sign the Federal Aid road maintenance agreement with NDDOT. Motion carried unanimously.

A motion was made by Bergstad and seconded by Boutilier to allow the sale of used bridge planks at ½ price of new, with a limit of 20 planks. The county reserves the right to stop sales at any time. Motion carried unanimously.

The county budget hearing was held. John and Claudette Merck and Marvin Block joined the meeting. The Merck's stated they support the county budget, but would like to see the state provide more funding to counties. With no other comments or questions, a motion was made by Boutilier and seconded by Bergstad to approve the budget as presented. Motion carried unanimously.

Tax Director, Becki Freund, met with the board to discuss the contract with Vanguard for residential properties. This software will be used to house parcel information as well as sales comparisons. The initial setup fee is \$14,000 with an annual fee of \$4,625. A motion was made by Bergstad and seconded by Medalen to sign the contract. Motion carried unanimously.

Emergency Manager, Kelsey Siegler, met with the board to discuss a request from the LEPC board to require house numbers on mailboxes or end of driveways throughout McHenry County to assist emergency service vehicles. In discussing the manpower and money needed for a project this size, the board opted to send a flyer in the tax statements asking individuals to post their house numbers. A motion was made by Boutilier and seconded by Haman to print colored flyers in-house. Commissioners Bruner and Boutilier voting aye. Commissioners Bergstad, Medalen, Haman voting nay. Motion failed. A motion was made by Haman and seconded by Medalen to print colored flyers at Staples. Commissioners Medalen and Bergstad voting aye. Commissioners Haman, Boutilier, Bruner voting nay. Motion failed.

A motion was made by Haman and seconded by Bruner to print the flyers in black and white in-house. Commissioners Haman, Bruner, Boutilier voting aye. Commissioners Bergstad and Medalen voting nay. Motion carried.

Kent Indvik with Wold Engineering met with the board to give an update on the bridge replacement project West of Upham.

The board recessed for lunch.

Dustin Welstad, Chief Deputy, met with the board in the absence of the Sheriff. The board asked Dustin to explain the CAD system the Sheriff's Dept has requested. The laptops needed for this system will be paid for by the Stonegarden grant. The board if the paperwork was in order so the impound vehicle sale could be held. Welstad said it should be done by November 6.

The board discussed the janitorial duties and will be reviewing the job description.

States Attorney, Josh Frey, met with the board regarding a civil asset forfeiture policy. The board was presented with a sample policy and application process. A motion was made by Haman and seconded by Boutilier to adopt the policy and application process. Motion carried unanimously.

Kevin Gefroh met with the board regarding right-of-way encroachments along roads. The board informed the county can only enforce encroachments along county roads. Township boards are responsible for township roads. The board will be reviewing all right-of-ways along county roads and landowners will be notified for encroachment violations.

The board set new minimum sales prices on the county land carried over from last year's sale as well as the properties foreclosed on this year due to delinquent taxes. A motion was made by Bergstad and seconded by Boutilier to approve the new minimum sales prices on these properties. Motion carried unanimously.

The board discussed the weather modification project in Ward County and will be sending a letter opposing the buffer zone into McHenry County.

The board set the sale for the impounded vehicles for November 13th at 10:00 AM. In case of inclement weather, it may be postponed until spring.

The board discussed bills presented for payment for items the county is not responsible to buy, according to the Sheriff's uniform policy. The board will hold these bills until they can talk to the Sheriff.

A consent motion was made by Bergstad and seconded by Medalen to approve the following: Treasurer's Miscellaneous Receipts #43943-44049; the monthly payroll in the amount of \$147,466.72 paid by warrant checks #25338-25395 and Social Service bills totaling \$4,495.92; Clerk of Court August County fees \$455.00, State fees \$10,060.83; Clerk of Court September County fees \$697.31, State fees \$8,126.95; Granville City \$16.00, Upham City \$20.00; County Recorder August recording fees of \$4,168.00 and misc fees of \$573.90; County Recorder September recording fees of \$5,777.00 and misc fees of \$245.30; Sheriff's August statement of fees \$620.00, Sheriff's mileage \$714.00; Sheriff's September statement of fees \$717.50, Sheriff's mileage \$671.00; Deputy reports for Aug/Sept.

The board continued to audit bills until completed. A motion was made by Haman and seconded by Boutilier that the following bills be approved and the proper checks be issued thereof:
