## OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

November 1, 2016

9:00 AM

Chairman Bergstad called the meeting to order. Commissioners Harry Bergstad, David Medalen, Gregg Boutilier, Bryan Bruner and Larry Haman were present.

A motion was made by Bruner and seconded by Boutilier to approve the October 4<sup>th</sup> minutes. Motion carried unanimously.

Travis Leier met with the board regarding road maintenance in Krumwiede Acres and the possibility of funding. Travis will meet with the township on this matter.

Peter Schaub met with the board regarding a conditional use permit and a variance permit submitted by Great River Energy to expand an existing substation located in Gov't Lot 4 Section 2-152-80. Schaub requested to store the topsoil and construction trailer on the South end of their property. A motion was made by Haman and seconded by Bruner to approve the variance application to be within 83' from the center of State Hwy 97 on the North side of their property and 63' from the center of 14th Ave N on the West side of their property. Motion carried unanimously. A motion was made by Bruner and seconded by Haman to approve the CUP including the additional request for the topsoil and construction trailer. Motion carried unanimously.

The board reviewed the CUP and variance application from Capital Power to construct a transmission line to be located in Sections 1, 12, 13, 14, 23, 26, 27, 33, 34 of 151-80 and Sections 3, 10, 15, 22, 23, 26, 35, 36 of 152-80. A motion was made by Haman and seconded by Bruner to approve the CUP and variance, in which the placement of the poles shall be determined by a consensus of the landowner, township and Capital Power. Motion carried unanimously.

The board reviewed the CUP application submitted by Crown Castle to upgrade an existing cell tower site located in the NE 1/4 south of the railroad right-of-way in Section 26-153-80. A motion was made by Medalen and seconded by Boutilier to approve the permit. Motion carried unanimously.

The board reviewed a variance permit submitted by Tyler McCabe to plant a shelterbelt 75' from the center of 10th Ave N along the SE ¼ of Section 14-155-79. A motion was made by Boutilier and seconded by Bergstad to approve the variance. Motion carried unanimously.

This being the time and place as advertised for the hearing on the county land minimum sale prices, and no one appearing in opposition, the prices will remain as previously set.

Callie Johnson and Rachel Wald, Extension staff, met with the board to give an update on their office projects.

Bill Behling from Capital Power briefly met with the board.

This being the time and place as advertised for the hearing regarding closing the section line lying between the SW ¼ of Section 26 and NW ¼ of Section 35 in 157-78. No one appeared against the closure. A motion was made by Boutilier and seconded by Medalen to approve closing the section line. Motion carried unanimously.

States Attorney Josh Frey met with the board to request additional office space. Also discussed were county timekeeping policies.

Kent Indvik, Greg Hagen and Jason Mayfield met with the board. Kent presented an overview of the county projects and informed the board they will need to make a decision on using federal aid money for the construction engineering costs. A motion was made by Medalen and seconded by Boutilier to proceed with the plans to regrade and pave the remaining five miles on Co Rd 16 West of Upham. Motion carried unanimously.

The board recessed for lunch.

A motion was made by Boutilier and seconded by Bergstad to furnish a 36" X 40' culvert to Grilley Township to be placed in Section 6. Motion carried unanimously.

The board conducted the interviews for the Tax Director position.

Commissioner Medalen left the meeting.

A motion was made by Bruner and seconded by Boutilier to offer the position to Tim Kraft. Motion carried unanimously. Medalen absent.

A consent motion was made by Bruner and seconded by Haman to approve the following: Treasurer's Miscellaneous Receipts #41152-41231; the monthly payroll in the amount of \$169,561.19 paid by warrant checks #23132-23192 and Social Service bills totaling \$3,932.72; Deputy reports for Sept/Oct.

The board continued to audit bills until completed. It was then the consensus of the board that the following bills be approved and the proper checks be issued thereof:
