OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

December 3, 2019

Chairman Bruner called the meeting to order. Commissioners David Medalen, Larry Haman, Bryan Bruner and Gregg Boutilier were present.

A motion was made by Boutilier and seconded by Medalen to approve the November 5th and 19th minutes. Motion carried unanimously.

Rachel Wald and Kendra Metcalfe met with the board to present an update on the happenings in the Extension Office and provide information on upcoming seminars.

The Chairman relinquished his chair to the auditor for the purpose of reorganizing the board. The auditor called for nominations for Chair. Haman nominated Bryan Bruner. A motion was made by Medalen and seconded by Boutilier that nominations cease and a unanimous ballot be cast for Bruner. Motion carried unanimously. The auditor called for nominations for Vice Chair. Boutilier nominated Larry Haman. A motion was made by Medalen and seconded by Boutilier that nominations cease and a unanimous ballot be cast for Haman. Motion carried unanimously. The auditor turned the meeting over to Chairman Bruner.

A motion was made by Boutilier and seconded by Bruner to approve Homestead Credit abatement #1317. Motion carried unanimously.

A motion was made by Boutilier and seconded by Haman to reissue lost instrument #78118. Motion carried unanimously.

A motion was made by Boutilier and seconded by Medalen to accept being the project sponsor to build a 10-foot wide sidewalk from the Highway 41 bridge to the Velva Golf Club and to approve a letter of support for the project. Motion carried unanimously. No county funds will be used toward the project.

A motion was made by Medalen and seconded by Boutilier to make the following appointments: Roger Myers – Zoning Board, Tom Krumwiede – Zoning Board, Teresa Proper – Park Board, Becki Freund – Tax Director, Maxine Rognlien – Supt. of Schools, James Davenport – Veteran Service Officer, Kelsey Siegler – Emergency Manager/911. Motion carried unanimously.

The board discussed traffic counts and load limits.

Denver Fosness and Steve Jacobson joined the meeting. The board opened the bids for the logjam removal in Falsen Township. A motion was made by Medalen and seconded by Haman to accept the low bid from Fosness Construction in the amount of \$19,900. Motion carried unanimously.

The board requested applications be sought for the open seat on the board due to the death of Commissioner Bergstad.

A motion was made by Boutilier and seconded by Bruner to purchase a snowblower for the county grounds. Motion carried unanimously.

The board recessed for lunch.

A motion was made by Haman and seconded by Boutilier to advertise for bids to widen a portion of Co Rd 10 in the NE ¼ of Section 36-153-76. Motion carried unanimously.

Harold Rotunda, CPA met with the board to review the 2018 county audit.

Sheriff Skager met with the board and reported the price of new vehicles and informed the board of the need to purchase new equipment since most of the equipment from the current vehicles won't fit in the new vehicles.

A consent motion was made by Medalen and seconded by Boutilier to approve the following: Treasurer's Miscellaneous Receipts #44139-44222; the monthly payroll in the amount of \$156,803.69 paid by warrant checks #25449-25512 and Social Service bills totaling \$43,335.28; Clerk of Court November County fees \$425.00, State fees \$8,471.87, Granville City \$40.00; County Recorder November recording fees of \$3,410.00 and misc fees of \$314.10; Sheriff October statement of fees \$607.00, Sheriff mileage \$926.00; Sheriff November statement of fees \$1,545.00, Sheriff mileage \$1,018.00, Deputy reports for Nov.
