## OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

April 7, 2020

9:00 AM

Chairman Bruner called the meeting to order. Commissioners David Medalen, Larry Haman, Bryan Bruner, Keith Cederstrom and Gregg Boutilier were present. Due to the COVID-19 recommendations, all visitors attended via virtual conference.

A motion was made by Boutilier and seconded by Cederstrom to approve the February 27<sup>th</sup>, March 3<sup>rd</sup> and March 19<sup>th</sup> minutes. Motion carried unanimously.

The board opened the bids for the Drake county shop demolition. Ralph Volson joined the meeting. A motion was made by Haman and seconded by Boutilier to accept the low bid. During the discussion, the board was informed of several individuals who were interested in purchasing the property. The motion failed unanimously.

A motion was made by Haman and seconded by Cederstrom to advertise the lot for sale as is. Motion carried unanimously.

A motion was made by Cederstrom and seconded by Haman to approve the special event permit for 10 North Main on August 28, 2020. Motion carried unanimously.

A motion was made by Medalen and seconded by Boutilier to approve the low bid from Mayo Construction of \$858,947.30 for the micromill and chipseal project known as SC-2500(020), West and South of Upham. Motion carried unanimously.

A motion was made by Boutilier and seconded by Cederstrom to reissue lost instrument #1205. Motion carried unanimously.

Abatements #1335-1337 were presented. A motion was made by Medalen and seconded by Boutilier to approve all abatements as they meet the requirements for Homestead Credits and Veteran Credits. Motion carried unanimously.

Brad Murphy and Brian Kraft with RDO joined the meeting. The board discussed the specs for the blades being bid next month.

A resolution was presented to the board to adopt the "Pandemic Illness Plan" as an appendix to the current Emergency Operation Plan for McHenry County. All commissioners voting in favor of approving the resolution, resolution passed.

A motion was made by Medalen and seconded by Boutilier to adopt the guidelines presented to comply with the Families First Coronavirus Response Act, and to add it as a policy amendment to the current personnel policy. Motion carried unanimously.

The board opened the bids for FEMA PW #66, which is a low water crossing in Deep River Township. A motion was made by Cederstrom and seconded by Boutilier to accept the low bid of \$368,300.00 from Dig It Up Backhoe. Motion carried unanimously.

Commissioner Medalen presented information regarding a hazardous bridge between section 18-158-79 and section 13-158-80. A motion was made by Medalen and seconded by Boutilier to temporarily close the road due to this hazard until the bridge can be repaired. Motion carried unanimously.

An offer was submitted regarding the cement bridge decking that was out on bids the last two months. The board agreed to place the decking in the online auction this summer.

The auditor presented the election changes recommended by the Governor's Executive Order 2020-13, which McHenry County will abide by, to hold the Primary Election by mail only and to provide a drop box outside the county courthouse for return ballots.

A motion was made by Bruner and seconded by Medalen to approve the encroachment policy and to publish notice in the paper. Motion carried unanimously.

The board recessed for lunch.

Ryan Ackerman joined the meeting to give a brief update on the new bridge construction on Hwy 41 at Velva.

A motion was made by Medalen and seconded by Cederstrom to deny payment of a Sheriff's Department bill to TransUnion. Motion carried unanimously.

A motion was made by Boutilier and seconded by Cederstrom to gravel 2 miles of Co Rd 17 and 2 miles of Co Rd 16. Motion carried unanimously.

A motion was made by Haman and seconded by Medalen to install an approach along Co Rd 17 on the North side of the road between sections 18 and 19 in Layton Township. Motion carried unanimously.

A consent motion was made by Haman and seconded by Bruner to approve the following: Treasurer's Miscellaneous Receipts #44430-44495; the monthly payroll in the amount of \$125,750.68 paid by warrant checks #25668-25716; Clerk of Court Feb County fees \$440.00, State fees \$7,458.50; Clerk of Court Mar County fees \$756.43, State fees \$17,525.60; County Recorder Feb recording fees of \$3,976.00 and misc fees of \$451.30; County Recorder Mar recording fees of \$4,140.00 and misc fees of \$299.80; Sheriff February statement of fees \$130.00, Sheriff mileage \$177.00; Sheriff March statement of fees \$790.00, Sheriff mileage \$889.30; Deputy reports for Feb/Mar.

The board continued to audit bills until completed. A motion was made by Cederstrom and seconded by Bruner that the following bills be approved and the proper checks be issued thereof:
