OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

July 7, 2020

9:00 AM

Chairman Bruner called the meeting to order. Commissioners David Medalen, Larry Haman, Bryan Bruner, Keith Cederstrom and Gregg Boutilier were present.

A motion was made by Medalen and seconded by Haman to approve the June 2nd and 26th minutes. Motion carried unanimously.

Abatements #1339 and #1340 were presented to the board. Both abatements were previously approved with the incorrect percentage. A motion was made by Haman and seconded by Cederstrom to approve the corrected amounts. Motion carried unanimously.

A motion was made by Cederstrom and seconded by Bruner to approve the gaming site authorization for the Velva Fire Department to conduct games of chance at the Star City Golf Club. Motion carried unanimously.

A motion was made by Boutilier and seconded by Cederstrom to approve a raffle permit for the Velva Wildlife Club. Motion carried unanimously.

A motion was made by Boutilier and seconded by Cederstrom to cancel warrant #1056 and send the funds to unclaimed property. Motion carried unanimously.

A motion was made by Haman and seconded by Medalen to approve the pledge of assets from Merchants Bank. Motion carried unanimously.

A motion was made by Cederstrom and seconded by Haman to resend the letter to the Towner County Commission, requesting a cost-share in the health insurance premium for the States Attorney and to send a copy of the letter to the States Attorney. Motion carried unanimously.

A motion was made by Haman and seconded by Medalen to hold another abandoned vehicle sale toward the end of October. Motion carried unanimously.

Jeff Kuntz, Larry Piatz and Chris Jorde joined the meeting. On behalf of a group of concerned citizens of the TGU School District, Jeff presented the board with their concerns regarding the use of funds in the school district and decisions the Superintendent has made without approval of the school board. This group is asking the county commission to require a complete audit of the school's finances as well as an investigation based on their allegations of misappropriation of funds and spending money without approval. The commissioners stated they do not have authority over a school board and referred them to the States Attorney.

Alex and Robert Kasowski met with the board regarding a decision on their overweight permit request. A motion was made by Haman and seconded by Boutilier to allow harvest permits up to 99,000 lbs through October 1, 2020. All trucks will be required to have the proper amount of axles and must not exceed 30 MPH when loaded. The fee will be \$50/truck/load. Commissioners Bruner, Boutilier and Haman voting aye. Commissioners Cederstrom and Medalen voting nay. Motion carried. This will be revisited again in October.

Anna Thorson and Elaine Hendrickson met with the board to give an update on the happenings with the McHenry County Historical Society and to ask the county to continue their financial support of .25 mills for 2021.

Becki Freund met with the board and presented a breakdown of parcel information by city and township regarding the Vanguard Appraisal proposal. A motion was made by Cederstrom and seconded by Medalen to not pursue an entire county reappraisal until it is mandated and cost shared by the state. Commissioner Cederstrom voted aye. Commissioners Medalen, Bruner, Haman and Boutilier voted nay. Motion failed. A discussion was held regarding to her budget request.

The board recessed for lunch.

Commissioner Haman absent.

Ryan Ackerman met with the board to present an update on the Mouse River Joint Board. Meetings have been scheduled for the Velva bridge replacement project. Due to the state revenue outlook, some projects may need to be deferred until funding is available.

A motion was made by Cederstrom and seconded by Boutilier to allow up to \$15,000 for gravel on the Kongsberg Road. Motion carried unanimously.

A motion was made by Medalen and seconded by Boutilier to approve the FDHU 2021 budget request. Motion carried unanimously.

A motion was made by Boutilier and seconded by Cederstrom to appoint Joe Weninger to the county Planning and Zoning Board. Motion carried unanimously.

A motion was made by Boutilier and seconded by Cederstrom to allow a portion of Co Rd 3 through Granville to be closed on July 25th for a street dance. Motion carried unanimously.

The board set a deadline of October 15th to go live with the surplus property online sale.

The board will hold a special meeting on July 21st at 10:00 to work on the county budget.

A motion was made by Boutilier and seconded by Cederstrom install culverts between sections 17/20 in Falsen Township and sections 25/26 in Norwich Township. Motion carried unanimously.

A consent motion was made by Bruner and seconded by Medalen to approve the following: Treasurer's Miscellaneous Receipts #44674-44760; the monthly payroll in the amount of \$127,256.57 paid by warrant checks #25817-25865; Clerk of Court May County fees \$625.00, State fees \$14,900.00, Velva City \$20.00; Clerk of Court June County fees \$682.93, State fees \$15,158.69, Granville City \$16.00; County Recorder June recording fees of \$3,942.00 and misc fees of \$380.40; Sheriff May statement of fees \$360.00, Sheriff mileage \$512.00, Deputy reports for May/June.

The board continued to audit bills until completed. A motion was made by Boutilier and seconded by Cederstrom that the following bills be approved and the proper checks be issued thereof:
