OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

June 2, 2020

9:00 AM

Chairman Bruner called the meeting to order. Commissioners David Medalen, Larry Haman, Bryan Bruner, Keith Cederstrom and Gregg Boutilier were present.

A motion was made by Cederstrom and seconded by Medalen to approve the May $5^{\rm th}$ and May $15^{\rm th}$ minutes. Motion carried unanimously.

A motion was made by Boutilier and seconded by Cederstrom to issue the proper deed to Jesse Nelson for the sale of county land described as Lot 9 less R/W of Block 5 in Jevnager's Addition in Balfour, and to cancel any remaining taxes. Motion carried unanimously.

A motion was made by Cederstrom and seconded by Boutilier to approve ND Game & Fish to install an approach along Co Rd 19 in the SE ¼ SW ¼ SW ¼ of Section 35-153-75. Motion carried unanimously.

The board discussed the request of Northern Prairie Human Services to purchase a sneeze guard for their reception area. The board recommended they find someone local to make one which would be less expensive. The board also discussed the new door lock request from this department. Since the three doors in question currently have working locks and two of the three doors are original to the courthouse which requires approval from the State Historical Society, and the estimates received from various companies to upgrade the locks are cost prohibited, the board agreed to continue with the current locks.

At the request of the board, representatives from the ND Insurance Reserve Fund and Workforce Safety met with the Sheriff's Department regarding their claims. The board received the loss history report from the ND Insurance Reserve Fund as well as a list of their training suggestions for county law enforcement to help reduce their claims. A summary report from the meeting will be received from Workforce Safety regarding their recommendations.

A motion was made by Medalen and seconded by Haman to remove the load restrictions effective immediately. Motion carried unanimously.

A motion was made by Medalen and seconded by Haman to remove the restrictions to the courthouse effective June 8th. Commissioners Haman, Medalen, Bruner, Cederstrom voting aye. Commissioner Boutilier voting nay. Motion carried.

Alex and Robert Kasowski met with the board regarding a decision on their overweight permit request. The board discussed the possibility of load testing that portion of road or another option would be to utilize the harvest permit which would allow for 10% over the weight limit. No decision was made at this time.

A motion was made by Cederstrom and seconded by Medalen to allow up to \$15,000 for gravel on Co Rd 21. Motion carried unanimously. Commissioner Cederstrom will talk to Capital Power to make sure they have completed their responsibility with this road.

Ryan Ehli with Vanguard Appraisals and Becki Freund joined the meeting. Ryan explained the procedure to complete a county reassessment and provided an estimated cost for McHenry County. There is a waiting list and the earliest it could be done is 2025. No decision was made at this time.

Kent Indvik joined the meeting and reported the milling project at Upham is scheduled to start June 9th. The board asked Indvik for his engineer's opinion regarding the overweight request from Kasowskis. Indvik stated that pavement is 26 years old and is not likely to withstand the heavy loads.

The board recessed for lunch.

A motion was made by Boutilier and seconded by Cederstrom to recess as a Board of Commissioners and convene as a Board of Equalization. Motion carried unanimously.

The board reviewed the city and township assessments. The board considered the following recommendations: Parcel 54-1-10258 to remove the residential structural value of \$8,800 due to the structure being torn down; Parcel 4-712-1 to add \$1,314 of ag value since the local assessor erroneously removed it; Parcel 9-1669-1 to change the classification of acres from ag to residential lot; Parcel 9-1658-1 to add \$1,300 of ag land since the local assessor erroneously removed it; Parcel 10-1761-2 to remove the residential values of \$98,300 since it became FRE; Parcel 11-2066-2 to remove the residential values of \$63,700 since it became FRE; Parcel 19-3723-2 to remove the residential values of \$43,300 since it became FRE; Parcel 20-3957-1 to remove the residential values of \$79,700 since it became FRE;. Parcel 27-5520 to remove the residential values of \$24,000 since it became FRE; Inundated land applications for Ole and Amy Bryn were reviewed on parcels 36-7259, 36-4001-12872, 42-8454. A motion was made by Medalen and seconded by Haman to approve the values as presented. Motion carried unanimously. A motion was made by Gederstrom to approve the inundated land applications. Motion carried unanimously. A motion was made by Medalen and seconded by Haman to approve a 4.4% increase in ag land values. Motion carried unanimously.

A motion was made by Boutilier and seconded by Cederstrom to recess as a Board of Equalization and reorganize as a Board of Review for the unorganized townships. Motion carried unanimously. The board reviewed the assessments, farm residence exemptions and homestead credits for the unorganized townships. A motion was made by Haman and seconded by Boutilier to approve the values as presented. Motion carried unanimously. A motion was made by Haman and seconded by Boutilier to approve the FRE's and homestead credits. Motion carried unanimously.

A motion was made by Cederstrom and seconded by Bruner to adjourn as a Board of Review and reorganize as a Board of Equalization. Motion carried unanimously. A motion was made by Cederstrom and seconded by Medalen to accept the changes for the unorganized townships. Motion carried unanimously. A motion was made by Cederstrom and seconded by Bruner to adjourn as a Board of Equalization and reconvene as a Board of Commissioners. Motion carried unanimously.

Becki Freund presented the board with the following zoning permits: B&J Excavating application for a CUP to mine gravel in the SW ¼ of Section 26-155-77. David Schmitt application to plant a shelterbelt within the setback from the section line in SE ¼ SE ¼ of Sec 27 and NE ¼ NE ¼ of Sec 34-154-76. The public hearings were held at the zoning board level, with no objections. A motion was made by Haman and seconded by Bruner to approve both permits. Motion carried unanimously.

A motion was made by Medalen and seconded by Haman to reconsider the previous motion to remove the restrictions to the courthouse effective June 8th and to amend the opening to June 15th in light of the fact the Primary Election will be held on June 9th so there will be no confusion as to an option for in-person voting. Motion carried unanimously.

A motion was made by Medalen and seconded by Haman to approve six loads of gravel to be placed on the TR Trail. Motion carried unanimously.

A motion was made by Boutilier and seconded by Bruner to approve to place gravel on Co Rd 19 from Hwy 41 to the Ward Co line. Motion carried unanimously.

A motion was made by Haman and seconded by Bruner to hold the abandoned vehicle sale on June 26th at 10:00 AM. Motion carried unanimously.

A consent motion was made by Boutilier and seconded by Cederstrom to approve the following: Treasurer's Miscellaneous Receipts #44587-44673; the monthly payroll in the amount of \$135,703.01 paid by warrant checks #25766-25816; County Recorder May recording fees of \$5,626.00 and misc fees of \$576.30; Sheriff May statement of fees \$160.00, Sheriff mileage \$190.00.

The board continued to audit bills until completed. A motion was made by Cederstrom and seconded by Haman that the following bills be approved and the proper checks be issued thereof:
