## OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

February 1, 2022

9:00 AM

Chairman Haman called the meeting to order. Commissioners Bryan Bruner, Larry Haman, Armann Anderson and Brady Nelson were in attendance. Duane Drader was also present.

A motion was made by Nelson and seconded by Bruner to approve the January 4<sup>th</sup> minutes. Motion carried unanimously.

David Schmitt met with the board to let them know he would be willing to fill in for a blade operator in all areas of the county.

Sheriff Skager met with the board to present quotes for two new deputy vehicles. New equipment in the vehicles will also be replaced since the current equipment will not fit in the new body styles. In a previous meeting, the board asked the Sheriff if the pickup acquired by the Sheriff's department through the asset forfeiture process could be used by the blade operators. Skager responded to that request, stating they would trade the use of the vehicle for use of the old county shop in Towner with heat and snow removal as well as access to all county shops and county vehicles. The commissioners asked about receiving a list of impounded vehicles to sell. Skager said he would provide a list of vehicles at the March commission meeting.

The board conducted an interview for the County Recorder position. A motion was made by Bruner and seconded by Nelson to appoint Johnna Torr upon the current Recorder's retirement. Motion carried unanimously.

A motion was made by Nelson and seconded by Anderson to advertise for a Deputy Recorder. Motion carried unanimously.

Jason Mayfield, with Wold Engineering, met with the board to discuss bridge funding. A motion was made by Nelson and seconded by Anderson to accept the ARPA funding to replace bridges 25-110-21.0 and 25-110.20.1, both North of Granville. Motion carried unanimously. Commissioner Medalen joined the meeting. Mayfield mentioned the UGPTI will be doing a bridge needs study which will hopefully put us in a good position for additional bridge funding.

A motion was made by Bruner and seconded by Anderson to enter into a funding agreement with the state for the 2023-2025 biennium to receive reimbursement for providing clerk services. Motion carried unanimously.

A motion was made by Nelson and seconded by Anderson to reissue lost instrument #1382. Motion carried unanimously.

The board discussed the opportunity to rent additional office space for the States Attorney's office and opted to continue with the current space.

The board reviewed the ag land values received from the state. No changes were made.

Two mobile homes were seized by the Sheriff's Department for 2021 delinquent taxes. A motion was made by Bruner and seconded by Anderson to advertise for sealed bids. Motion carried unanimously.

A motion was made by Medalen and seconded by Anderson to deny abatement #1358. Motion carried unanimously.

A motion was made by Medalen and seconded by Nelson to place a question on the June ballot for public input for the continuance of the levy for the Historical Society. Motion carried unanimously.

A motion was made by Medalen and seconded by Bruner to place a measure on the ballot to continue to levy for the following funds: Farm to Market, County Road & Bridge, County Road. Motion carried unanimously.

A consent motion was made by Medalen and seconded by Nelson to approve the following: Treasurer's Miscellaneous Receipts #46245-46310; the monthly payroll in the amount of \$138,540.25 paid by warrant checks #26753-26798.

The board continued to audit bills until completed. A motion was made by Bruner and seconded by Anderson that the following bills be approved and the proper checks be issued thereof:
