OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

February 6, 2024

9:00 AM

Chairman Nelson called the meeting to order. Commissioners Brady Nelson, Bryan Bruner, Duane Drader, Lance Johnson and Armann Anderson present.

A motion was made by Anderson and seconded by Johnson to approve the January 2nd minutes. Motion carried unanimously.

The quarterly EM/911 report was presented to the board.

A motion was made by Bruner and seconded by Drader to approve abatements 1528-1572. Motion carried unanimously.

Brad Murphy and Frank Anderson from RDO Equipment met with the board to discuss options for buying out the current motor graders.

Rachel Wald introduced the new Extension Agent, Lesley Jones to the board. Rachel gave an update on the programs she has been involved in and the classes coming up. Her annual review has been scheduled for February 13th at 10:00. At least one commissioner will be attending. She mentioned one of the toilets is not working properly. A motion was made by Armann and seconded by Bruner to have someone look at it and repair as needed. Motion carried unanimously.

Max Erickson with Oldcastle Infrastructure met with the board to inform them of the production of cement box culverts being made in Devils Lake.

No bids were received for the collection of scrap iron. The board will have the blademen take it in as time allows.

Ryan Ackerman and Sabrina Herrmann with Ackerman Estvold met with the board to present an update on the Mouse River Flood Protection plan. The new bridge on Hwy 41 near Velva is planned to be bid this fall.

Minot Housing Authority called to discuss the new rental rates. Since Pierce County was not in attendance, no business was conducted.

A motion was made by Drader and seconded by Johnson to follow the state timeline for when load restrictions go on. Motion carried unanimously.

J Rom met with the board to discuss his concerns with the road maintenance in his area.

Jason Mayfield informed the board funding for the Sallee Bridge and the Upham Bridge got pushed back a year. The three bridges North of Granville are still on schedule to be replaced this summer.

The board recessed for lunch.

Ryan Ehli with Vanguard and Kristi Brodehl met with the board to discuss the plan to implement the Vanguard program. Tablets will be purchased and training for all assessors will be scheduled for June, after the busy assessment season is over.

A motion was made by Anderson and seconded by Drader to buy out the lease on the four blades that are coming due this year. Motion carried unanimously. Funding will need to be secured so the Auditor will look into financing options.

Sheriff Skager met with the board to request the purchase of eight radios at approximately \$6,500/radio. Four radios have previously been purchased through the Stonegarden Grant program. A motion was made by Johnson and seconded by Anderson to purchase eight radios at approximately \$56,000. Motion carried unanimously.

A motion was made by Drader and seconded by Bruner to appoint Nicole Hildenbrand to the Northern Prairie Human Service Zone. Motion carried unanimously.

A motion was made by Johnson and seconded by Anderson to appoint Matt Zelinski, Zoning Chair, as a McHenry County Steering Committee member with Souris Basin Planning Council. Motion carried unanimously. The steering committee will provide guidance to assist livestock development planning activities through a Regional Livestock Development and Planning Grant by the ND Department of Agriculture and administered through Souris Basin Planning Council.

The board discussed the funding shortfall in the Road & Bridge account and will need to look into options to mediate this.

A consent motion was made by Anderson and seconded by Johnson to approve the following: Treasurer's Miscellaneous Receipts #48255-48350; the monthly payroll in the amount of \$142,306.45 paid by warrant checks #27906-27944; Sheriff December statement of fees \$1,697.00, Sheriff mileage \$759.00; Deputy reports for Nov.

The board continued to audit bills until completed. A motion was made by Bruner and seconded by Drader that the following bills be approved and the proper checks be issued thereof:
