Chairman Anderson called the meeting to order. Commissioners Brady Nelson, Armann Anderson and Lance Johnson were present. Commissioners Bryan Bruner and Duane Drader absent.

A motion was made by Nelson and seconded by Johnson to approve the December 3rd minutes. Motion carried unanimously.

A motion was made by Johnson and seconded by Nelson to approve abatements 1610-1613. Motion carried unanimously.

Sheriff Skager requested an adjustment to the starting wage of a new deputy. Skager asked the board to allow credit for half (approximately 3 years) of service while employed as a deputy in another county. A motion was made by Johnson and seconded by Nelson to approve this request. Motion carried unanimously.

The auditor requested to allocate earned vacation hours monthly rather than annually. The board will discuss this at the next meeting.

A motion was made by Nelson and seconded by Johnson to obligate the remaining ARPA funds to buy out the motorgraders. Motion carried unanimously.
