OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

December 3, 2024

9:00 AM

Chairman Nelson called the meeting to order. Commissioners Brady Nelson, Duane Drader, Armann Anderson and Lance Johnson were present. Commissioner Bryan Bruner absent.

A motion was made by Drader and seconded by Anderson to approve the November 19th minutes. Motion carried unanimously.

For the purpose of reorganizing the board, Chairman Nelson relinquished his chair to the Auditor. The auditor called for nominations for Chair. Nelson nominated Armann Anderson. No other nominations were made. A motion was made by Nelson and seconded by Drader that nominations cease and a unanimous ballot be cast for Anderson. Motion carried unanimously. The auditor called for nominations for Vice Chair. Nelson nominated Bryan Bruner. No other nominations were made. A motion was made by Anderson and seconded by Johnson that nominations cease and a unanimous ballot be cast for Bruner. Motion carried unanimously. The auditor turned the meeting over to Chairman Anderson.

Kelani Welstad joined the meeting. A renewal for a beer and liquor license was presented to the board for 1481 Meats. A motion was made by Nelson and seconded by Johnson to approve the off-sale only licenses. Motion carried unanimously.

The board was presented with a retirement notice from Northern Prairie Human Service Zone Director, Kelly Jensen.

A motion was made by Nelson and seconded by Drader to approve the joint powers agreement with Ward County to provide juvenile housing. Motion carried unanimously.

The board was reminded of the presentation to be given at the next Planning & Zoning meeting on December 12th, relating to regional livestock development planning.

Gary Deibert joined the meeting.

A motion was made by Johnson and seconded by Nelson to purchase four tires for the Granville blade. Motion carried unanimously.

A motion was made by Nelson and seconded by Drader to limit an \$85 per day allowance for all county board members. Motion carried unanimously.

Lesley Jones, Family and Community Wellness agent and Kathryn Slavick joined the meeting. Lesley introduced Kathryn to the board, as she has been hired to fill the County Agent position. Lesley presented some information about the FARMS program, in which they will be looking for producers who are innovated and interested in new technology.

Johnna Torr joined the meeting.

The board opened the bids for the electrical work at the new Upham shop. One bid was received from B & G Electric in the amount of \$23,400. A motion was made by Drader and seconded by Johnson to accept this bid. Motion carried unanimously.

Trey Skager, Natasha Kuhnhenn, Breanna Zimbelman, Kyleen Kitzman, Grace Swartzentruber, Mandy Peterson, Josh Frey, Miriam Smette, Natalie Goodman and Sarah Heit joined the meeting for the discussion regarding storm closures for the courthouse. A motion was made by Nelson and seconded by Johnson to follow the TGU School District for late start/early closure days. Motion carried unanimously. On days when school is not in session, the Sheriff and Commission Chair will make the decision. If employee leave was scheduled prior to a closure day, the employee would be required to take the scheduled leave rather than being paid for the closure time. Only employees scheduled to work in the county will be eligible for paid time for closures. The reverse 911 system will be utilized to notify employees of storm closures.

Commissioner Bruner joined the meeting via phone.

Lucille Loftesnes and Dale Deibert joined the meeting. Along with Gary Deibert, who had previously joined, they requested the county road South of Granville and west to Hwy 41 be paved. They expressed their concern for safety, as the road is used quite heavily by gravel trucks which creates a lot of dust. The board explained funding is an issue, and current funds need to go toward repairing bridges. Gary requested the county enforce Strata to water the road.

Lesley Jones and Kathryn Slavick met with the board to assist in conducting an interview for the administrative assistant position in the Extension Office.

Commissioner Bruner left the meeting.

Commissioner Johnson reported he is waiting for Swingen Construction to look at the Hanretty Bridge to get their recommendation on repairing this structure.

The board recessed for lunch.

Commissioner Bruner joined via phone. Commissioner Drader absent.

Lesley Jones and Kathryn Slavick joined the meeting to hold another interview for the administrative assistant position.

Trey Skager, Dustin Welstad, Josh Frey and Ryan Welsh met with the board to request a higher compensation for a starting deputy. No changes were made. A question was also asked about how years of service are calculated.

Lesley Jones and Kathryn Slavick joined the meeting to discuss the candidates for the administrative assistant position. A motion was made by Johnson and seconded by Nelson to offer the position to Holly Christianson. Motion carried unanimously.

A motion was made by Bruner and seconded by Johnson to make the necessary repairs to the sign truck. Motion carried unanimously.

The board was notified of the resignation of the Veteran Service Officer, which will be effective next summer.

The board discussed some productivity concerns with the Towner blade operator. This will be discussed at the next meeting when his supervisor can be present.

A motion was made by Nelson and seconded by Johnson for McHenry County to affirm to North Dakota Public Employees Retirement System that McHenry County is formed pursuant to N.D.C.C. 11-01-26 and is neither a non-profit corporation nor a for-profit corporation, to join the NDPERS Public Safety Defined Benefit Retirement Plan and offer the plan to all eligible employees of McHenry County. The motion was seconded by Johnson. Motion carried unanimously. The Board approved joining the NDPERS Public Safety Defined Benefit Retirement Plan effective January 1, 2025.

Due to deterioration of Co Rd 19, a motion was made by Bruner and seconded by Nelson to discontinue selling overweight permits for the Karlsruhe highway and to have the unused permits returned to the county for a refund. Motion carried unanimously.

A consent motion was made by Bruner and seconded by Johnson to approve the following: Treasurer's Miscellaneous Receipts #49482-49597; the monthly payroll in the amount of \$199,275.25 paid by warrant checks #28406-28465; County Recorder November recording fees of \$3,740.00 and misc fees of \$190.51; Deputy reports for Oct/Nov.

The board continued to audit bills until completed. A motion was made by Johnson and seconded by Nelson that the following bills be approved and the proper checks be issued thereof. Motion carried unanimously.
