## OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

November 7, 2024

9:00 AM

Chairman Nelson called the meeting to order. Commissioners Brady Nelson, Duane Drader, Armann Anderson and Lance Johnson were present. Commissioner Bryan Bruner absent.

A motion was made by Johnson and seconded by Drader to approve the October 1<sup>st</sup> minutes after one correction was made. Motion carried unanimously.

Frank Anderson with RDO Equipment met with the board to inform them about a product called John Deere Path which is designed for low visibility and will show the edge of the road in real time.

Pat Schaff joined the meeting.

Travis Sauber met with the board to discuss the conditional use application from JDE Holdings to place their air coolers outside of the data center facility on the north side of the building and a possible covering. A motion was made by Johnson and seconded by Anderson to approve the CUP. Motion carried unanimously.

The plat describing Buffalo Lodge Cottage 6<sup>th</sup> Addition was presented to the board for their approval. The verbiage on the plat has been corrected to state the road will not be dedicated to the public. A motion was made by Johnson and seconded by Anderson to approve the plat. Motion carried unanimously.

The Granville EDC requested permission to place a Christmas tree at the north end of Main Street from November 30<sup>th</sup> through January 4<sup>th</sup> and to close Main Street on December 7<sup>th</sup> from 1:00-5:00 PM to hold a scavenger hunt with the businesses. A motion was made by Drader and seconded by Johnson to approve the requests. Motion carried unanimously.

A motion was made by Nelson and seconded by Drader to purchase 20 concrete barrier blocks. Motion carried unanimously.

The hearing for the prices set on the foreclosed property was opened. No one appeared for or against, so the prices will remain as set.

Bill Metzger, Aaron Bryn, Patrick Wagner, Kyle Bailey and Johnna Torr joined the meeting. On behalf of the Towner Rural Fire Department, Bill requested permission to place an approach on the East side of Co Rd 5 North of Towner in order to allow another access to the new fire hall. Their preferred access would be an approach on the south side of the property connecting to Hwy 14, but NDDOT has denied that request. Both the State and the County have distance requirements to where approaches can be built due to safety and snow hazards. States Attorney, Josh Frey joined the meeting. The commission will present this situation to the engineer when they meet with him later in the day.

The board searched for possible options after receiving notice from the State for the immediate closure of the Hanretty Bridge due to a recent inspection.

Jason Mayfield joined the meeting. The board asked for his recommendation on the placement of the approach for the Fire Department. He stated access to Hwy 14 on the South side would be better due to the greater distance from the intersection. The board will contact NDDOT to request their reason for denial before making a decision on the approach. Jason presented the results from the magnetic particle report from the Hanretty Bridge, which determines the severity of the cracks. The report did not have good findings. A motion was made by Anderson and seconded by Drader to close the bridge. Commissioners Nelson, Drader and Anderson voting aye. Commissioner Johnson voting nay. Motion carried. Jason presented the board with a list of the poor bridges in the county and asked the board to prioritize them. Each commissioner will prioritize four or five bridges in their district and present their list at the next meeting. Jason had an example of a 20-year road maintenance plan that Wold Engineering completed for another county.

Miriam Smette and Josh Frey met with the board to discuss her compensation adjustment made at the previous meeting. Josh mentioned the amount approved by the board was not the amount he was asking for. The auditor presented information on how Miriam's compensation is calculated, the hours on which it is based and what her hourly rate was before any adjustments. The States Attorney's office is calculating the rate of pay on 27.5 hours per week which creates a higher hourly pay. A motion was made by Drader and seconded by Johnson to set the pay at \$29.71/hr for Victim Witness duties and \$25.16/hr for administrative duties. Motion carried unanimously.

The board requested a letter be sent to Raymond Jaeger, asking him, within the next 30 days, to place a cattle guard with steel gates to allow public access between Sections 15/22 in 155-76.

A motion was made by Johnson and seconded by Drader to rescind the expired burn ban. Motion carried unanimously.

A motion was made by Johnson and seconded by Drader to pass a resolution to adopt burn restrictions through November 15, 2025 which will follow the fire index rating set by the State. Motion carried unanimously.

The board was presented the quarterly report for the Emergency Manager.

A motion was made by Johnson and seconded by Anderson to appoint Ted Klatt to fill the vacant seat on the LEPC which represents private industry. Motion carried unanimously.

A motion was made by Drader and seconded by Johnson to reappoint Joan Gunter and Jerry Effertz as county delegates on the ND State Fair Board. Motion carried unanimously.

A motion was made by Anderson and seconded by Drader to approve abatements #1589-1606. Motion carried unanimously.

A motion was made by Anderson and seconded by Johnson to issue the proper deeds for the redemption of county property described as follows: Dale Kampa - Lots 13-14 of Block 9 in Original Bergen; Richard Roberts – Lots 4-9 of Block 4 in Original Granville; Blaine Isakson – SE ¼ less r/w in Section 34-158-79; Krystofer Yost – Lots 3-9 in Block 1 of Original Balfour, Lots 1-6 of Block 1 of Jevnagers Addition in Balfour, Lots 3-4 in Block 4 of O'Hara's Addition in Balfour; Betty Haller – S ½ of Lots 7 & All of Lots 8-12 of Block 1 in Jevnagers Addition in Balfour. Motion carried unanimously.

A motion was made by Anderson and seconded by Johnson to approve raffle permits for the Velva Wildlife Club and the Velva FFA, pending approval from the Attorney General's office. Motion carried unanimously.

A motion was made by Johnson and seconded by Anderson to approve the special event permit for Finishline Burgers and Brew for an event on November 30<sup>th</sup>. Motion carried unanimously.

A motion was made by Johnson and seconded by Drader to apply for the scheduled delivery program for the Lake Hester shop with Enerbase. Motion carried unanimously.

A motion was made by Johnson and seconded by Drader to advertise for electrical bids for the new Upham shop. Motion carried unanimously.

A consent motion was made by Johnson and seconded by Anderson to approve the following: Treasurer's Miscellaneous Receipts #49347-49481; the monthly payroll in the amount of \$161,045.63 paid by warrant checks #28356-28405; Clerk of Court October County fees \$844.75, State fees \$40,119.86, City of Velva \$20.00, ND Dept of Trust Lands \$50.00; County Recorder September recording fees of \$4,029.00 and misc fees of \$339.10; County Recorder October recording fees of \$3,012.00 and misc fees of \$274.34; Sheriff October statement of fees \$1,320.00, Sheriff mileage \$1,265.40; Deputy reports for Sept/Oct.

The board continued to audit bills until completed. A motion was made by Anderson and seconded by Drader that the following bills be approved and the proper checks be issued thereof. Motion carried unanimously.
