OFFICIAL PROCEEDINGS OF THE MCHENRY COUNTY BOARD OF COMMISSIONERS

September 3, 2024

9:00 AM

Chairman Nelson called the meeting to order. Commissioners Bryan Bruner, Brady Nelson, Duane Drader and Lance Johnson were present. Commissioner Anderson absent.

A motion was made by Johnson and seconded by Drader to approve the August 6th minutes. Motion carried unanimously.

Ryan Ackerman and Sabrina Herrmann joined the meeting to provide information regarding the flood protection projects as well providing maps indicating the different flooding issues at various flood events. Structural improvements are being considered at specific locations to keep roads and bridges from overtopping during these events.

Tom Alexander met with the board via phone to discuss a resolution to transfer the housing voucher program to the Minot Housing Authority. Tom will send information regarding how the board would be organized.

The board reviewed the conditional use and variance application from JDE Holdings to place a data center 50' from the section line in the SE ¼ of Section 24-156-77. Travis Sauber explained the data center would be an un-manned facility, liquid-cooled with a glycol product to reduce noise pollution. Verendrye Electric would dictate the power capacity and have determined they would be limited to 5 MW. The building would be 50' x 50' due to the level of power. A motion was made by Nelson and seconded by Johnson to approve the conditional use permit only. Motion carried unanimously.

Rachel Wald, Leslie Jones and Shana Forster joined the meeting. Leslie and Rachel gave the board an update on the activities they have been involved with. Rachel informed the board she has resigned from her position and her last day will be September 20th. NDSU will advertise to fill her position.

A motion was made by Drader and seconded by Bruner to hire Rocking BS Construction to replace the culvert in Co Rd 3 between sections 32/33 in Granville Township. Motion carried unanimously.

A motion was made by Johnson and seconded by Drader to purchase culverts. Motion carried unanimously.

A motion was made by Bruner and seconded by Johnson to approve the utility permit request from Verendrye Electric to bore under Co Rd 6 between sections 16/17 in Bjornson Township. Motion carried unanimously.

A motion was made by Drader and seconded by Johnson to purchase 10 fire extinguishers for the Sheriff vehicles, as per quote. Motion carried unanimously.

Jason Mayfield met with the board and reported the three bridges North of Granville have been replaced with box culverts, but Keller Paving will need to come back and complete the paving within specs. The board discussed the repairs needed for the Howe Bridge. Jason will put a list together of the closed and low-limit bridges.

A motion was made by Bruner and seconded by Drader to remove "swather" in the notice to mow ditches. Motion carried unanimously.

A motion was made by Johnson and seconded by Bruner to approve Homestead Credits 1594-1597. Motion carried unanimously.

A motion was made by Bruner and seconded by Drader to sell used bridge plank for 50% of new price. Motion carried unanimously.

A consent motion was made by Johnson and seconded by Drader to approve the following: Treasurer's Miscellaneous Receipts #49115-49212; the monthly payroll in the amount of \$172,183.23 paid by warrant checks #28261-28309; Clerk of Court June County fees \$397.88, State fees \$16,147.45; Clerk of Court July County fees \$535.62, State fees \$20,197.23, Velva City \$20.00; County Recorder July recording fees of \$4,332.00 and misc fees of \$433.78; Sheriff June statement of fees \$560.00, Sheriff mileage \$669.00; Deputy reports for June/July.
